



## INVITATION TO BID FOR THE Concreting of Farm to Market Road at Nanaguan

- 1. The City Government of Ilagan, sourced from the <u>GENERAL FUND for the year 2022</u>, intends to apply the sum of <u>FIVE MILLION PESOS (P5,000,000.00)</u> being the Approved Budget for the Contract (ABC) to payments under the contract for the <u>Concreting of Farm to Market Road @ Nanaguan</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Ilagan now invites bids for the <u>Concreting of Farm to Market Road @ Nanaguan</u>, located at <u>brgy</u>. <u>Nanaguan</u>, City of Ilagan, Isabela. Completion of the works is required for <u>forty five (45) calendar days</u>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Implementing Rules & Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Interested bidders may obtain further information from the City Gov't. of Ilagan and inspect the bidding documents at the <u>BAC Secretariat Office</u> during Office hours.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>Feb. 14-15, 2022</u> from the <u>BAC Secretariat Office</u> and website below and upon payment of a nonrefundable fee for the bidding documents in the amount of <u>FIVE THOUSAND PESOS (P5,000,00) Only.</u>
  It may also be downloaded free of charge from the website of the PhilGEPS & the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
- 6. The **City Government of Ilagan** will hold a Pre-Bid Conference on <u>Feb. 18, 2022</u> @ 2:00 pm at the <u>Conference Room</u>, <u>City Hall</u>, <u>City of Ilagan</u> which shall be open to all prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat on or before <u>2:00 pm</u>, <u>March 03, 2022 at</u> <u>Conference Room, City Hall, City of Ilagan, Isabela</u>. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB clause 16.
- 9. Bid opening shall be on <u>2:00 pm , March 03, 2022 @ conference Room. City Hall</u>. Bids will be opened in the presence of the bidder's authorized representative who choose to attend the activity. Authorized representative must bring letter of authorization from the board , owner or proprietor. 10.
